Motion by Jim Roland, supported by Alice Craig to approve the resurfacing of Kennedy Road at a cost of \$401,000.00. This includes the pulverizing of existing asphalt, the asphalting of the road, and the shoulder work. This work is expected to be completed this year. Motion carried.

Motion by Alice Craig, supported by Matt Hyzer for Resolution 07-2019, Central Huron Ambulance Service Agreement at \$4.00 per person of the population of Hume Township starting April 1, 2019 thru March 31, 2020 for ambulance service. Roll call vote taken, all ayes. Motion carried.
