Motion by Theresa Mazure, supported by Alice Craig for Resolution #04-13 Trustee Salary as follows; \$60.00 per meeting and \$1,240.00 yearly Stipend for fiscal year 2013 – 2014. Roll call vote taken, all ayes. Motion carried.

Motion by Jim Roland, supported by Theresa Mazure to continue with Michigan Municipal League as our insurance carrier at a cost of \$3,241.00 per year which is an increase of \$14.00 from the prior year, we will also receive a dividend of \$424.00. Burnham and Flowers quote was \$3,670.00 per year. Motion Carried.

Gave permission to Jim Roland to talk to Port Austin Township about the possibility of dumping any resident's yard waste by the Water Treatment Plant in Port Austin. Jim will let us know at the February 2013 meeting as to what agreement, if any, they would entertain.

Huron County Road Commission has imposed bridge weight restrictions on Witherspoon Road, this is one of four bridge weight restrictions the county road commission has imposed through out the county. There is very little, if at all, any traffic on Witherspoon Road and it is a dead end road.
